**Note (1) – A Mayor must within 28 days of becoming aware of any changes to interests specified in the paragraphs above, provide written notification to the authority’s Monitoring Officer of that change.**

**Note (2) – Where a Mayor considers that the information relating to any personal interests is sensitive information (that is information whose availability for inspection by the public creates, or is likely to create, a serious risk that the member or a person who lives with the member may be subjected to violence or intimidation) and the Combined Authority’s Monitoring Officer agrees, the Mayor need not include that information when registering that interest or a change to that interest. A Mayor must within 28 days of becoming aware of any change of circumstances that information excluded under this provision is no longer sensitive information, notify the Combined Authority’s Monitoring Officer asking that the information be included in the Register of interests.**
